The batteries are not hazardous when used according to the instructions of manufacturer under normal conditions and built in a metal or high-quality plastic case, designed to withstand temperatures and pressures encountered during normal use. As a result, during normal use, there is no physical danger of ignition or explosion and chemical danger of hazardous materials' leakage. However, if exposed to a fire, added mechanical shocks, decomposed, added electric stress by misuse, a pressure release vent/s will be operated in the cell pack and hazardous materials may be released. Moreover, if heated strongly by the surrounding fire, acid or harmful fumes may be emitted.

Environmental Precautions	Prevent product from contaminating soil and from entering sewers or waterways.
Methods and Materials for Containment	Stop the leak if safe to do so. Contain the spilled liquid with dry sand or earth. Clean up spills immediately.
Methods and Materials for Cleaning Up	Absorb spilled material with an inert absorbent (dry sand or earth). Scoop contaminated absorbent into an acceptable waste container. Collect all contaminated absorbent and dispose of according to directions in <i>Section 13</i> . Scrub the area with detergent and water; collect all contaminated wash water for proper disposal.

Handling	The battery may explode or cause burns, if disassembled, crushed or exposed to fire or high temperatures. Do not short or install with incorrect polarity.
Storage	Store in a cool, dry, well-ventilated area away from incompatible substances. Store locked up. Keep out of the reach of children.
Other Precautions	In case of rupture, handle in accordance with good industrial hygiene and safety practice. Avoid contact with skin, eyes or clothing. Use personal protection equipment.
